The Ontario Cannabis Legalization Implementation Fund ("OCLIF") will provide funding over two years to municipalities to help with the implementation costs of recreational cannabis legalization;

The first payment will be processed in January, 2019. An allocation notice setting out the amount of the second payment will be sent out by March, 2019.

Ongoing funding to municipalities is dependent on their decision to opt-in or opt-out of hosting private retail stores in accordance with the Cannabis Licence Act by January 22, 2019.
