BLYAW 2023-033: TO REDUCE SPEED LIMIT

WHEREAS Council has been presented with Bylaw 2023-033 being a Bylaw to decrease the speed of motor vehicles from statutory speed limits;

1. When any highway or portion of highway set out below is marked in compliance with the regulations under the Highway Traffic Act, the maximum rate of speed thereon shall be 60 (sixty) kilometres per hour.

Townline Road, 742m East of Sideroad 15 to 242m East of Sideroad 15

2. Whereby any highway or portion of highway set out below is marked in compliance with the regulations under the Highway Traffic Act, the maximum rate of speed thereon shall be 40 (forty) kilometres per hour.

Townline Road, 242m East of Side Road 15 to West end of Townline Road

3. The penalties provided in Part IX, Section 128(14) of the Highway Traffic Act shall apply to offences against this bylaw.

This By-law shall become effective upon the date, and at the time, of its enactment.

the REEVE or DEPUTY REEVE

AND

ONE of the CLERK-ADMINISTRATOR, DEPUTY TREASURER or DEPUTY CLERK-ADMINISTRATOR or ADMINISTRATIVE ASSISTANT

DOCUMENTS TO BE EXECUTED BY THE CLERK-ADMINISTRATOR

The following types of documents shall be executed by the Clerk-Administrator:

- a) Any agreement or other document intended to be registered in the Land Titles Office
- b) Any applications for a funding agreement in which the application for the funding program was approved by way of Bylaw or Resolution of the Council
- c) Memoranda of Agreement or Memorandum of Understanding between the municipality and the Province; the Federal Government; another municipality or School Board
- d) Agreements or other documents related to the functions of the Treasurer, including, but not limited to, banking, taxation, grants, accounts payable and accounts receivable:

THAT Bylaw 2022-022 and any amendments thereto be and is hereby repealed effective the date of passage of this bylaw;

THAT this Bylaw shall come into force and effect as on the date of enactment.
