Chief's Report August/September 2025

Weekly practice nights are continuing. The new pumper truck from Pickering has arrived and is in service so we have been training with it. Spectrum will be coming shortly to remove the radio from the old pumper and install in it in the new one. We have received an offer of \$4,000 for the old pumper from B.A.M.M. in M'Chigeeng. This is the amount I was hoping to get for it when it was sold. Brandon needs it to take the parts from it to repair the fire truck for another local municipality. I recommend to council that we proceed with this sale as it will be helping a neighbor department.

The annual pump testing has been completed with only some minor repairs required. Repairs and ladder testing will be completed in October. I seen a large volume Honda trash pump on GovDeals recently. This is a good thing to have with the recommendation from Clean Water that we avoid using the hydrants in South Baymouth as much as possible. It was in Norwich so I picked it up after one of my weekends in Walkerton.

I successfully passed my Firefighter II in Walkerton. This means I am now a certified firefighter and compliant with the Ontario regulations coming July 2026. I have requested that the Ontario Fire College set Tehkummah up with an Exterior Attack learning contract so that we can get everyone certified to that level and then move on from there. The goal is to have everyone or at least a significant number of the crew certified to the same level as I am. CJ has returned from Sudbury and would like to be reinstated to the roster but only at the Firefighter level.

We had our Emergency Management Committee meeting this week and have set the date and topic for this years Table top exercise. We will be doing a major incident at the water treatment plant.

Topic: Disposition of Municipal Assets

Purpose: To obtain direction for the disposition of municipal assets.

Background:

I would like to tender out the 2010 Peterbilt plow truck, wing and plow. I would like to also tender out items such as a 3-point hitch snowblower, a street sweeping broom that connects to the bucket of a tractor, and two older water pumps from when the marina was built.

We have multiple items that are laying around not being used or are scrap items. There are numerous scrap I-beams from the Rogers Creek bridge, unused fuel tanks, a water tank and a truck box that are all no good for our daily operations. We have snowplows that do not fit any of our applications and are from the 1960's to 1980's and would like to also send these items to the scrap yard. The 2003 Sterling plow truck at the landfill should also go for scrap. It does not run anymore due to engine problems; it's missing numerous parts and is in poor condition. We could try to tender the truck for sale but if it does not have any interest then it could go for scrap.

BYLAW NUMBER 2025-21

BEING A BYLAW TO CONFIRM THE PROCEEDINGS OF COUNCIL

Legal Authority

Scope of Powers

Section 8(1) of the *Municipal Act*, 2001, S.O. 2001, c.25, ("*Municipal Act*") as amended, provides that the powers of a municipality shall be interpreted broadly so as to confer broad authority on municipalities to enable them to govern their affairs as they consider appropriate, and to enhance their ability to respond to municipal issues.

Powers of a Natural Person

Section 9 of the *Municipal Act* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act.

Powers Exercised by Council

Section 5 (1) of the *Municipal Act* provides that the powers of a municipality shall be exercised by its Council

Powers Exercised by By-law

Section 5(3) of the *Municipal Act* provides that a municipal power, including a municipality's capacity, rights, powers and privileges under section 9, shall be exercised by bylaw unless the municipality is specifically authorized to do otherwise.

Preamble

Council for the Corporation of the Township of Tehkummah ("Council") acknowledges that many of the decisions it makes during a meeting of Council, regular, special, or otherwise, are done by resolution. Section 5 (3) of the *Municipal Act* requires that Council exercise their powers by Bylaw.

Council further acknowledges that the passing of resolutions are more expedient than adopting Bylaws for each decision.

Decision

Council of the Corporation of the Township of Tehkummah decides it in the best interest of the Corporation to confirm its decisions by way of Confirmatory Bylaw.

Direction

NOW THEREFORE the Council of the Corporation of the Township of Tehkummah directs as follows:

- 1. The Confirmatory Period of this By-Law shall be for the Council Meeting of October 9, 2025.
- 2. All By-Laws passed by the Council of the Corporation of the Township of Tehkummah during the period mentioned in Section 1 are hereby ratified and confirmed.
- 3. All resolutions passed by the Council of the Corporation of the Township of Tehkummah during the period mentioned in Section 1 are hereby ratified and confirmed.
- 4. All other proceedings, decisions, and directives of the Council of the Corporation of the Township of Tehkummah during the period mentioned in Section 1 are hereby ratified and confirmed.

5. This Bylaw takes effect on the day of its final passing.

Read and adopted by Resolution 2025-187 this 9th day of October 2025.
