WHEREAS The perennial garden situated between Township and Seniors' Hall parking lots has been established by volunteers over many years

AND WHEREAS the retaining walls to the garden need replacement on the west side

THEREFORE, BE IT RESOLVED THAT the \$2,005.87 which remains unused in the former recreation committee bank account be spent to cover the purchase, delivery and placement of a line of limestone rock to function as a new retaining wall on the west side of the garden.

BACKGROUND:

The Tehkummah Triangle Seniors' Club has relinquished responsibility for garden maintenance and new volunteers have begun rejuvenating this established public space. The original railway ties used for retaining the garden have deteriorated substantially on the west side of the garden; replacing this side with limestone rock will be a decorative and functional solution for both the garden and parking lot definition.

The funds in the recreation committee bank account were raised by Patti McKenzie beginning in 2018 (Council Motion 2018-114). Patti withdrew her name from the committee December 5, 2020. These funds, which were raised for a recreational facility, have remained unutilized for approximately seven years.

Topic: School Bus Signage

Purpose: To obtain directions for the installation of School bus signage

Background:

We have recently received a request for the installation of bus turning signage on the 15th Side Road, to accommodate a school bus pick-up and turnaround near the intersection of 15th Side Road and 4th Concession.

Upon reviewing the location, I have determined that the pick-up area presents a reduced visibility concern, as it is situated on the crest of a hill. To enhance safety for both the school bus operation and general roadway users, I recommend installing two "Bus Turning/Pick-Up Ahead" signs at the following locations:

- **Southbound direction:** Approximately 75 meters north of the Government Road and 15th Side Road intersection.
- Northbound direction: Prior to the bus pick-up location on 15th Side Road.

This signage will serve to alert motorists of the bus activity ahead, particularly during periods of increased traffic associated with ferry operations. Given the limited sightlines and high traffic volume in this area, I consider this installation a necessary measure to improve roadway and student safety.

Please advise if you require further details or if approval can be granted to proceed with the installation.

THE CORPORATION OF THE TOWNSHIP OF TEHKUMMAH

BYLAW NUMBER 2025-22

BEING A BYLAW TO CONFIRM THE PROCEEDINGS OF COUNCIL

Legal Authority

Scope of Powers

Section 8(1) of the *Municipal Act*, 2001, S.O. 2001, c.25, ("*Municipal Act*") as amended, provides that the powers of a municipality shall be interpreted broadly so as to confer broad authority on municipalities to enable them to govern their affairs as they consider appropriate, and to enhance their ability to respond to municipal issues.

Powers of a Natural Person

Section 9 of the *Municipal Act* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act.

Powers Exercised by Council

Section 5 (1) of the *Municipal Act* provides that the powers of a municipality shall be exercised by its Council

Powers Exercised by By-law

Section 5(3) of the *Municipal Act* provides that a municipal power, including a municipality's capacity, rights, powers and privileges under section 9, shall be exercised by bylaw unless the municipality is specifically authorized to do otherwise.

Preamble

Council for the Corporation of the Township of Tehkummah ("Council") acknowledges that many of the decisions it makes during a meeting of Council, regular, special, or otherwise, are done by resolution. Section 5 (3) of the *Municipal Act* requires that Council exercise their powers by Bylaw.

Council further acknowledges that the passing of resolutions are more expedient than adopting Bylaws for each decision.

Decision

Council of the Corporation of the Township of Tehkummah decides it in the best interest of the Corporation to confirm its decisions by way of Confirmatory Bylaw.

Direction

NOW THEREFORE the Council of the Corporation of the Township of Tehkummah directs as follows:

- 1. The Confirmatory Period of this By-Law shall be for the Council Meeting of November 4, 2025.
- 2. All By-Laws passed by the Council of the Corporation of the Township of Tehkummah during the period mentioned in Section 1 are hereby ratified and confirmed.
- 3. All resolutions passed by the Council of the Corporation of the Township of Tehkummah during the period mentioned in Section 1 are hereby ratified and confirmed.
- 4. All other proceedings, decisions, and directives of the Council of the Corporation of the Township of Tehkummah during the period mentioned in Section 1 are hereby ratified and confirmed.
- Read and adopted by Resolution 2025-195 this 4th day of November 2025.
