IF A PERSON OR PUBLIC BODY does not make oral submissions at a public meeting or make written submissions to the Township of Tehkummah and/or The Manitoulin Planning Board before the By-law is passed, the person or public body is not entitled to appeal the decision of the Township of Tehkummah to the Ontario Land Tribunal (OLT)

IF A PERSON OR PUBLIC BODY does not make oral submissions at a public meeting or make written submissions to the Township of Tehkummah and/or The Manitoulin Planning Board before the By-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT), unless, in the opinion of the Board, there are reasonable grounds to do so.
